If you've had problems and have reason to believe any of these people were directly or indirectly involved, we'd like to hear your story. Please send a short description of the circumstances, and why you think the **Desais** may be involved, to IdentityTheftByLawyer@gmail.com. **Riddhi Desai** is also believed to be heavily involved in immigration fraud (including perjury and false claims of abuse or political persecution) – if you know the verifiable details of a case where she has fraudulently obtained immigration status for someone (or where an immigration status matter has been delayed or revoked because **Riddhi Desai** was not satisfied with her money payment), and you or that someone are willing to step forward, we would like to hear from you as well. We are not a government agency, and your information will be kept in strict confidence.
